Land & Labor Acknowledgement

Multnomah county rests on the stolen lands of the Multnomah, Kathlamet, and Clackamas Bands of Chinook Indian Nation; Tualatin Kalapuya; Molalla; and many others along the Columbia River. This country is built on stolen Indigenous land and built by stolen African people. This land was not stolen and people were not enslaved by ambiguous entities and actors. Community Agreements

- 1. Account for power dynamics in the room and in the work.
- 2. Assume best intentions while honoring impact. Acknowledge that intent does not trump impact.
- 3. Be accountable. Commit to acknowledging and working through harm caused.
- 4. Be mindful of privilege, historical structures of oppression, and the shared goal to lead with a lens of equity, inclusion, diversity, and anti-racism.
- 5. Expect and accept non-closure.
- 6. Honor the diversity in the room and stay open to different perspectives. There may be several different roads that lead to a great outcome.
- 7. Language matters. Use intentional, direct, non-violent language. Speak your truth responsibly.
- 8. Make space, take space. Make space for those who are not speaking up as often, take space if you usually don't speak up.
- 9. Maintain confidentiality, share lessons learned while keeping names and identifiers confidential.
- 10. Meet folks where they are at. Do not assume knowledge on behalf of others. Be thorough, clear, and transparent in our dialogue.
- 11. Refrain from stigmatizing language and use people-first language.

Charter Revision Proposal

Background and Process

Section N: Additions

In situations where action by the CoC Board is necessary on an emergency basis in fewer than five working days, notice of a special meeting will be given at least 24 hours in advance, and business at that meeting will be limited to such emergency action. If a quorum of the CoC Board is not established at such an emergency meeting, the CoC Board members present at the meeting may proceed to make decisions without a quorum, provided that all members of the Jurisdictional Committee are present.

Charter Revision Proposal

Section I: Revisions

The CoC Board shall establish a Jurisdictional Committee to:

- Support continuity of the CoC board's work in the interim between CoC Board meetings and make decisions with the board in 'emergency' cases as described in Section N
- Follow strategic guidance and direction as established by the CoC Board
- Ensure cross-jurisdictional interests and priorities are included in the direction of the Continuum of Care
- Engage in monthly communication with and monitoring of the CoC HMIS Lead and Collaborative Applicant.

The Jurisdictional Committee will be comprised of three Ex-Officio members to include City of Portland represented by the Portland Housing Bureau, City of Gresham represented by Gresham Housing Services, and Home Forward and the Co-Chairs of the CoC Board. The Jurisdictional Committee is responsible to the CoC Board; the Jurisdictional Committee will be required to report all discussions and actions to the CoC Board. Jurisdictional Committee meeting minutes will be submitted to the CoC Board.

HMIS Lead Designation

- For 2022 HMIS Lead Portland Housing Bureau
- Same MOU that has been in effect since 2018, updated to reflect the change in CoC Advisory Board structure
 - "Old" and "new" MOUs provided in CoC Member Packet
- New MOU/HMIS Governance Charter to come with the new HMIS
 Tri-County implementation and the change to JOHS as the HMIS Lead in
 December or the beginning of 2023
