Q&A	 (Q) Budget and NOFA process - Annual Report 70% of allocated funds, Article in local media says QI reports only 7% of budget. What is the process of allocating funds for NOFA. (A) JOHS has limited capacity to influence how our work is portrayed in the media. Ist year of SHS revenue was \$16million above budgeted amount of \$32million, which contributes to the 'underspending'. Future year projections should be more on target. Expecting \$107million this year. Each NOFA (Notice of Funding Availability) release has its own timeline. Takes approximately 3 months from NOFA release until applicant notification (Q) Is it possible for committee members to review reports that are currently being given to JOHS. (A) Not our practice to send our reports that are provided. We share our Quarterly reports. (Q) What are the metrics of the provider reports? (A) We evaluate shelter beds funded / number of individuals served / demographics of people we serve / exiting from housing. (Q) Requests update Build for Zero. (A) will organize a BfZ presentation for this committee soon 	
Annual Report & Quarterly Report	 Population A & Population B comes from Supportive Housing Services (SHS) measure - Joint Office of Homeless Services (JOHS) providers have to determine population A & B as part of intake. <u>Population A</u> - People who are 0-30 AMI, has at least 1 disabling conditions, 12 months of the last 3 years of homelessness, someone who has been institutionalized, intensive case services, <u>Population B</u> - Anyone experiences any type of homelessness or at risk of homelessness. Expectation that, at end of 10 years, 75% of SHS funds will serve people in Population A; this is not an annual goal We know that, over time, more people currently in Population B will come into Population A. Prevention therefore becomes important

Feedback	 Question regarding data - annual report states that those who identify as male are served at a lower, disproportionate rate. Concerns over Housing and Urban Development (HUD) utilization of Vulnerability Index Service Prioritization Data Assessment Tool (VISPIDAT) to assess who should be prioritized for Permanent Supportive Housing (PSH) in the continuum. Tool seen as transphobic, and known to have a racial bias New assessment tool under development Will there be additional RFI's to add more qualified agencies for the Tri-County SHS funding? "I would like to recommend we tease out in reporting people served in housing and people served in shelters of all kinds as this measure's intent was for perm housing."
