Old Business:	<p>Use of the Fist to Five Technique to make group decisions</p> <ul style="list-style-type: none"> If there is no consensus after using this technique, then during a following meeting the group will use majority voting only to resolve decisions that are time sensitive. If there is a tie, the Chair (Dani Vogel) has stated to remove their vote if needed JOHS CBAC is not currently listed in the Multnomah County charter as an approved Community Budget Advisory Committee. The County Commissioners are aware and have been informed of possible solutions. No other updates. 	
New business: CBAC timeline	<p>Recommendation from JOHS staff: Review the program offers for the JOHS budget which is what the Board of Commissioners are voting on. JOHS will send the program offers by the Friday following the CBAC meeting.</p> <p>Questions:</p> <ul style="list-style-type: none"> How many program offers are there? About 50 different offers, 80%-90% are continued program offers from the previous budget. 	

	<ul style="list-style-type: none"> • What does "out of target" mean?" This is determined by the Board of Commissioners, out of target means items that do not currently have a funding source but JOHS would like to complete these items. Program offers were submitted on February 24th. <p>Suggestion from JOHS staff to have JOHS present an overview of the FY24 Budget then the CBAC can choose priorities and frame their recommendations around how to assess and meet the out of target requests.</p>

- What does it cost Multnomah County to operate one shelter bed for one day, on average?
- How many program offers are there?
 - Answer: Bates: Unclear/unsure (140/3 => ~47?)
- How many are continuing vs new?
 - Answer: Bates: ~80%, but some have been combined
- Is there a guide or could we be guided on *how to read the budget*?
- Is there a spreadsheet version of the program offers?
- What does “out of target” program offers mean in this context? - Answer: Bates: These are things we’d *like to do* vs things that are already funded by general funds
- When were the program offers submitted?
 - February 24

Daniel Questions:

Overall:

- Is there a way to access this as a spreadsheet?
- Equity outcomes: measurement vs booleans?
- 30900 - ARP - Shelter Operations (motels), ~\$17million
 - Target outcomes/outputs declined, but cost increased?
- 30902 - Expanded Hygiene Access, \$750k
 - Measurement of impact/effectiveness of hygiene access? e.g. reduction in covid cases for homeless, etc?
- 30905 - Outdoor Shelters / Safe Rest Villages, \$14,864,912
 - FY2023 budget 393, but estimate 273?
 - What is the *construction* cost per unit of shelter?

- At 780 estimate served, that's ~19k per person a year?

30906 - Placement out of Shelter, \$6,472,330

- "Permanent housing" – measurement of how many retain housing after placement?

30907 - Emergency Rental Assistance, \$3,611,270

- Rental market impact assessment?

- Distribution of funding across management companies / landlords?
