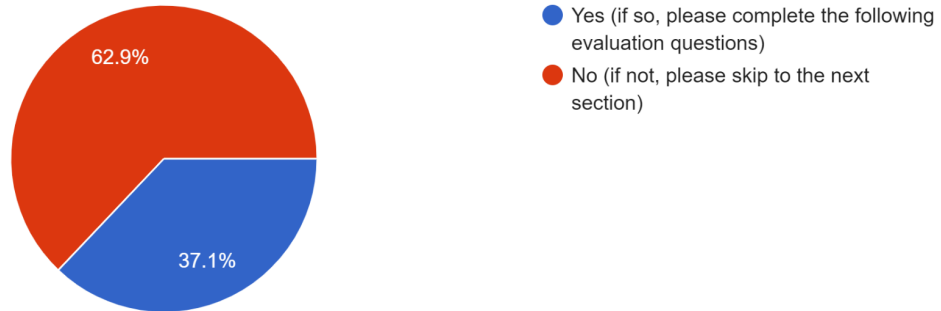

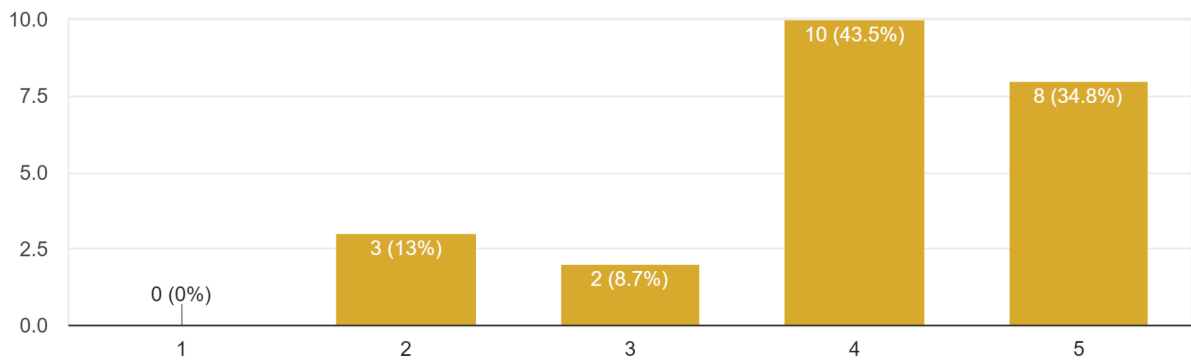

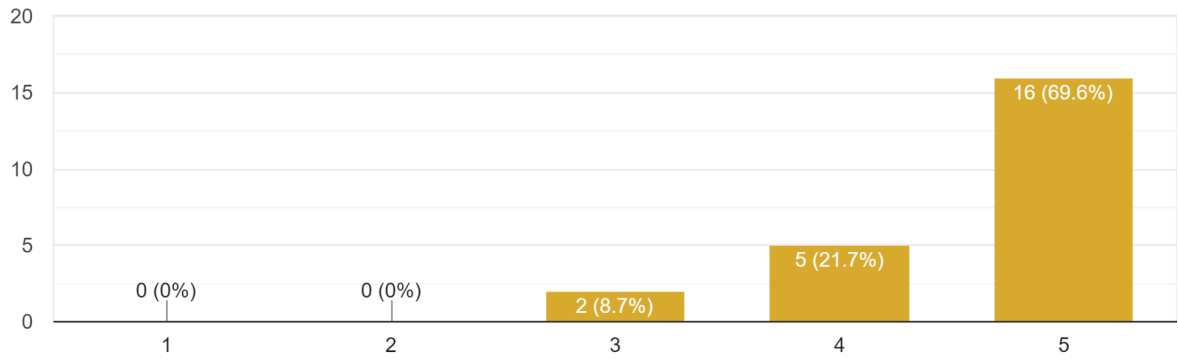

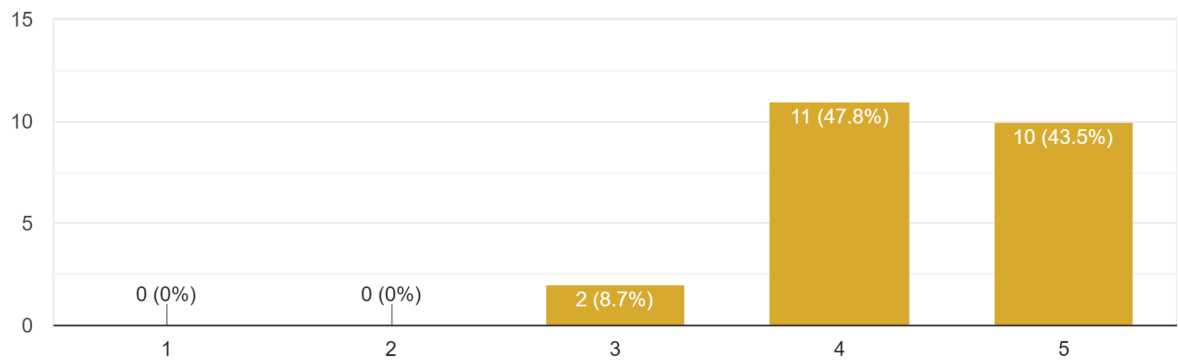

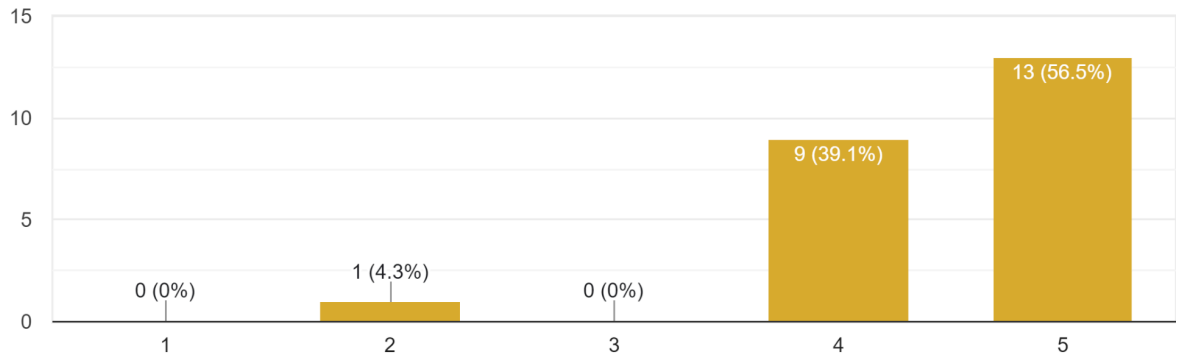

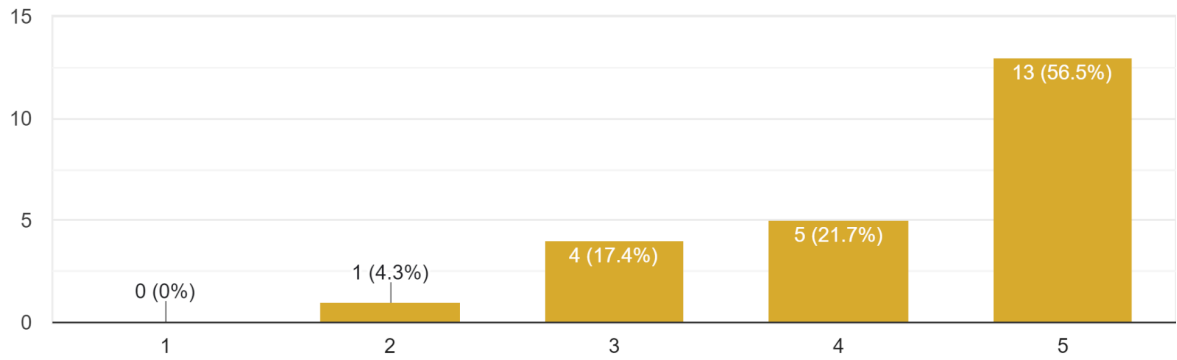

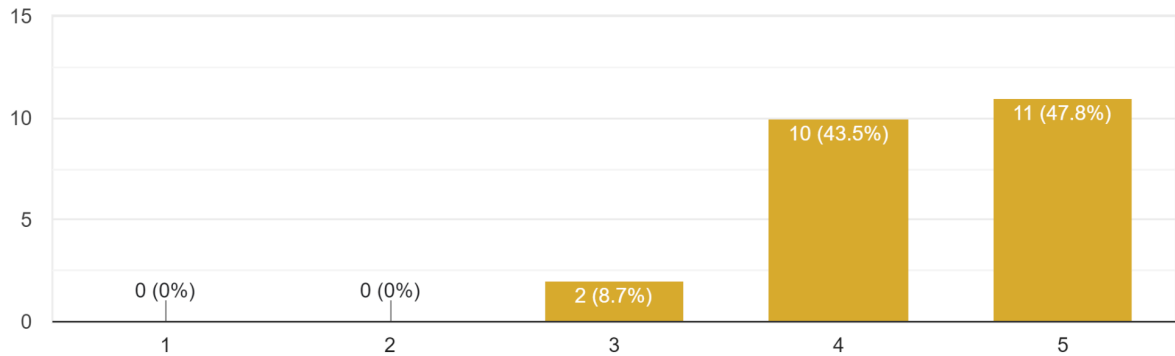

- I would shift some of the focus away from the forms (unless we're covering ways that providers can get involved in that process) -- and give more direct information on how immigrants of various statuses might interact with our services and benefit from a better understanding of the immigration process.

- I would have liked more connection/conversations re: the housing piece for this population and what we as service providers can do to better support them and what the expected timeline for the lawyers have to work with people or how quickly one could expect them to engage and begin working with them. I also would like to have a bit more information about the additional resources and culturally congruent services available to connect people with, housing and other basic support needs, who need assistance.
- Maybe shorter on presentations and longer on questions - opportunity to break up the discussion into small groups.
- Increase resources for the immigrant and refugee community that reflect and address the system-imposed challenges with obtaining income and access to social safety net and housing resources.
