 Section 1: Intersectionality & Equity in SHS Work It makes sense to me to consider an individual's multiple identities regarding services. Feels thoughtful/intentional. I agree that it is harder for those experiencing one or more of these. What about explicitly naming people impacted by drugs (drug users, recovery, war on drugs) given that is disproportionately experienced by people of color (+1). People coming out of jail are not considered homeless; SHS funds may need to fund projects that work with people leaving incarceration. New County Homelessness Response Action Plan/ Homeless Response System acknowledges the need for service alignment. People exiting incarceration will be prioritized in this work. Goal of reducing release to homelessness from incarceration by 2026. Example given by member about their post-incarceration 	

	 experience and the challenge in getting trauma informed services and appropriate housing upon release. Consider adding details related to services for people leaving incarceration and people surviving DV/IPV (maybe use language from member with actual experience?.) Prioritizing transitional and long term housing that is safe and supportive for those exiting incarceration and do not exhibit carceral-like conditions that retraumatize. Section 2: Evaluation & Accountability Clarification: Is this section specifically about organization performance who have been funded? Or is this also about the evaluation of organizations seeking funding? For folks currently getting funded. We don't currently have clarity about how the services are being provided in an equitable way. Call for more accountability in outcomes, including recommendations from people with lived experience. Pause discussion for next meeting.

 Discussion: What 2 things from emerging themes would the committee like to focus on? What high level priorities are missing from the list? Member advocates for evaluation to improve accountability. Who is watching the work to see how the work is happening. Accessibility/Equity (+1) Accessibility/Programming Programming and Accessibilitythough hard to prioritize. Collaboration doesn't explicitly say collaboration with people with lived experience. Accessibility and collaboration Programming/evaluation have to be able to show our work, and better work happens when people pay attention. And. add accessibility Is there a pie chart that exists that would show the current % of SHS funds allocated to each of these areas? Not really: these are not really tags for our funding, but these are areas that are important Can equity and evaluation be folded in together, like person-centered evaluation? For accessibility-focus on people who have difficulty accessing services. Some groups are excluded from services b/c there aren't services structured to serve them. My other thought is that there should be rights and advocacy training included for consumers of services/ so perhaps that would be under evaluation/accessibility? 1 know this is kind of granular, but 1 know people feel hopeless and powerless against these systems and aren't aware of their rights. Things are only likely to get worse for folx with the recall of measure IIO and the lack of meaningful services or interventions.

Next Steps	 committee lift up 'consumer' or service user-level evaluation for their experiences in services? Results hopefully can improve programs. Consumer experience is a great word as it reframes those seeking support. Incentives are a great motivator! Pay people for their expertise and contribution. For JOHS, evaluation begins with contractual evaluation, then do we see outcomes in HMIS data? May need a different definition for evaluation to reflect recommendations from the committee. But those systems don't take in qualitative data which is really hard to evaluate. (+1) Evaluation needs a clear rubric that can help review consumer experience.
