The 2025 Portland tri-county Point-in-Time (PIT) Count is coming up!

The count will occur the week of January 23 - 29, 2025.

Every year our communities come together to count and learn more about the people experiencing homelessness in our region.

Be on the lookout in the coming weeks for information on how you can support the PIT.



Purpose & Goals of PIT

The U.S. Department of Housing and Urban Development (HUD) requires communities that receive Continuum of Care (CoC) funding to conduct a Point in Time (PIT) Count.

Starting in 2023 Multnomah, Clackamas, and Washington Counties have collaboratively endeavored to conduct a Tri-County coordinated PIT to fulfill this requirement.



What the PIT does - and doesn't do

PIT does tell us -

- About people's characteristics, including race, disability status, and age.
- Approximately what areas, people are staying

PIT does not tell us -

- Exactly how many people are experiencing homelessness in the tri-county area
- All personal or identifiable data about people



What's next for the PIT?

- Keep an eye out for a message from PSU / HRAC team in the next week, with an ask to:
 - Join upcoming planning meetings, where we'd like to hear from you
 - Provide contact information for you and your organization to stay up-to-date- on PIT happenings
- In December & January, look for:
 - Messages about training sessions for using CountingUs this year and/or paper forms
 - Information about where and how we hope your organization can administer the Point in Time Count with us
 - Details about durable goods kits and logistics related to their distribution
