<p>Adults</p> <p><i>Unaccompanied adults, adults in couples, and households with dependents 18 and older. The head of household must be literally homeless (in shelter, a place not meant for human habitation, transitional housing), in an intuition <u>and</u> at risk of exiting to homelessness, in housing <u>and</u> will become literally homeless within 14 days, or fleeing or attempting to flee domestic violence.</i></p>	<p>If someone at your organization is trained to conduct the assessment, refer in-house. If not, the Coordinated Housing Access Team (CHAT) is the main point of access.
