## Land & Labor Acknowledgement

Multnomah County rests on the stolen lands of the Multnomah, Kathlamet, and Clackamas Bands of Chinook Indian Nation; Tualatin Kalapuya; Molalla; and many others along the Columbia River. - Respect names and pronouns (help others when they may make mistakes).
- Stay focused/stay present.
- Understand we are all collectively learning and growing.

## **Equity Recommendations**

## The group's recommendations fell into three categories:



### INTERSECTIONAL EQUITY

Consider intersectional identities when developing SHS programming, & involve folks most impacted by disparities in housing & homelessness in discussions, communications, and decision making.



# EVALUATION & ACCOUNTABILITY

Identify specific equity goals, provide clear guidelines, and ensure accountability.



#### EQUITY INVESTMENTS

- direct cash assistance
- long-term rent assistance
- priority populations
- small, new, and emerging organizations

## Framing the Conversation: Priorities

<u>What</u> are we talking about?

Each year the committee identifies its top two SHS priorities and prepares recommendations. Priorities help guide meeting content for that year.

#### <u>Why</u> is it important?

The committee has an opportunity to make recommendations about the topics it would most like to influence.

## **2024 Priorities Identification Process**

- June: Initial Discussion at In-Person Committee Retreat
- July: Committee Meeting brainstorm
- August: Committee Meeting discussion, priorities survey
- September: Committee Meeting discussion
- November: Committee Meeting vote
- **December:** Priorities finalized for calendar year 2025

## **Committee Priorities This Year**

### Accessibility

Improve access to homelessness and housing services in Multnomah County.

### Collaboration

Increase service system coordination within Multnomah County and with external partners.

# What to Expect

### Sample Priorities Process

- Timeline: ~6 months per topic
- Phases:
  - Define priorities
  - Gather information
  - Brainstorm recommendations
  - Develop, discuss & edit recommendations
  - Vote & submit to Joint Office Leadership

# **Goals for Today**

- Discuss how the committee would like to define these top two priorities. This will give the committee some parameters to work within during the recommendations process.
- Identify if there is a priority the group would like to start with first. It may be helpful to develop recommendations for one priority at a time, although the topics may have some overlap.

# Accessibility & Equity

One way to think about accessibility is through a racial equity framework.

Some resources that help us understand inequities in access:

- HUD 2023 PIT Count: Provides demographic breakdowns of individuals and families experiencing homelessness.
- Multnomah County Annual Report Racial Equity Analysis: Compares the percentage of people receiving SHS services identifying as BIPOC to the demographic breakdown of our total population experiencing homelessness.
